

#### Did you know?

Your Estate Planning documents won't do you or your family any good if no one can find them. Sit down with your family, especially the one who you've designated as a health care agent, and explain what you've decided. Give them a copy of your documents and let them know where the originals are.

Review your papers every few years. Keep them in a safe, easily accessible place such as a secure file cabinet. Avoid a safe deposit box if you are the only one with access to it. The process to open it if you are unavailable will be unnecessarily burdensome on your family. If your family situation changes through the arrival of grandchildren, for example, or a divorce, you probably will want to make changes.

## Think Now to Avoid Family Confrontation Later

People don't want to think that an accident or illness would prevent them from saying what they want or don't want, when it comes to their future medical care. We tell ourselves: I have plenty of time to take care of those things later.

But things do happen in our lives that are out of our control. Your family and friends need to know how you want them to handle situations if you're too ill to tell them. If they're left guessing, a conversation can quickly disintegrate into a confrontation. The fallout can result in guilt, uncertainty and arguments. Know what you need and contact an Estate Planning Attorney.

A living will alerts medical professionals and your family to the treatments you want to receive or refuse, and under what conditions. This will only go into effect if you meet specific medical criteria and are unable to make decisions.

A health care power of attorney delegates a spouse, trusted family member or friend to make health care decisions for you if you are unable to do so. Be aware that a regular durable power of attorney only covers financial matters. You will need separate Powers of Attorney for finances and health care.

A Power of Attorney is a legal document in which you give another person legal authority to act for you. It allows your agent to carry out financial tasks for you when you cannot do so. This might include paying your bills, managing your property, and handling other money matters. It can also involve more complex matters like selling real estate.

Put it in writing, but remember a letter of instruction is not technically a legal document. Contact an Estate Planning Attorney so they can apprise you of any relevant changes in the law that might affect your documents.
